

Terms & conditions for durga puja adani preview 2026 pass

These terms govern access to and participation in the durga puja adani preview 2026.

1. Eligibility

The durga puja adani preview 2026 pass is open to all individuals who demonstrate a genuine interest in durga puja as a premier cultural festival. Applicants must meet the following criteria:

- Provide complete and accurate personal information during the registration process
- Acknowledge an appreciation for durga puja, cultural experiences and public festivals
- Agree to comply with all venue-specific guidelines and regulations

Durga puja adani preview 2026 reserves the right to verify the information provided and may request additional documentation if deemed necessary.

2. Personal information and data protection

By registering for the durga puja adani preview 2026 pass, you consent to the collection and processing of your personal information. We are committed to protecting your privacy:

- All personal data collected will be used exclusively for managing the preview pass and related communications
- Your information will be handled in strict accordance with applicable privacy and data protection laws
- We will not share your personal information with any unauthorized third parties

3. Pass benefits and privileges

The durga puja adani preview 2026 pass entitles holders to exclusive benefits designed to enhance their durga puja preview experience:

- Priority access to designated preview areas during specified times
- Opportunity to view durga puja installations in a placid environment
- Special interactive sessions with participating puja organisers and cultural participants
- Complimentary program guides where available

Benefits are subject to availability and may vary by venue or preview event.

4. Code of conduct

All pass holders are expected to maintain appropriate behavior throughout their attendance. The following conduct will not be permissible:

- Any form of harassment, discrimination, or abusive behavior toward staff, artists, or other attendees
- Damaging, defacing, or tampering with durga puja installations, venue property or event infrastructure
- Creating excessive noise or disruption that interferes with others' enjoyment
- Entering restricted areas or violating safety barriers
- Intoxication or inappropriate behavior that may pose a risk to yourself or others

5. Photography, recording, and media usage

With respect to photography and media capture during the event:

- Flash photography may be prohibited in certain areas to protect sensitive durga puja installation
- Commercial photography or recording requires prior written permission
- By attending, you grant durga puja adani preview 2026 permission to photograph, film, and record you during the event
- Durga puja adani preview 2026 may use these images and recordings for promotional, educational, and archival purposes across various media platforms without additional compensation

6. Changes, cancellations, and rescheduling

Durga puja adani preview 2026 strives to deliver all scheduled programming as advertised, however:

- Preview content, artist appearances, and session times may be subject to change without prior notice
- In the event of unforeseen circumstances, including but not limited to weather conditions, artist unavailability, venue issues, or public health concerns, sessions may be modified, rescheduled, or cancelled
- Notification of significant changes will be communicated via event's registered social media.
- Durga puja adani preview 2026 will make reasonable efforts to provide alternative arrangements where possible

7. Liability and waiver

Regarding liability during your attendance:

- Your participation in the durga puja adani preview 2026 is entirely at your own risk
- Durga puja adani preview 2026, its organizers, partners, and venue owners accept no responsibility for any personal injury, property damage, or loss sustained during your attendance
- You agree to indemnify and hold harmless durga puja adani preview 2026 from any claims arising from your actions or negligence
- Durga puja adani preview 2026 does not assume responsibility for lost, stolen, or damaged personal belongings
- You acknowledge that certain durga puja installations may involve interactive elements and assume all associated risks
- We are only aggregating the participating pujas. Each puja committee remains solely responsible for its own terms and conditions, and all visitors are required to comply with the respective puja's terms and conditions.

For effective communication regarding your pass:

- All queries, concerns, or requests should be directed to the official contact channels provided in your registration confirmation
- Durga puja adani preview 2026 will primarily communicate through your registered email address or phone number
- You are responsible for ensuring your contact information remains current and for monitoring communications from durga puja adani preview 2026
- Response times may vary based on query volume, especially near event dates

9. Confirmation process

Regarding the confirmation of your pass application:

- Only applicants who meet all eligibility criteria will receive official confirmation from durga puja adani preview 2026
- Confirmation may be sent via email, text communication, or other specified communication channels
- The confirmation will contain important details about your pass, including access instructions and schedules
- You must present your confirmation along with valid identification at the venue

10. Ineligibility and application rejection

In cases where applications do not meet requirements:

- Applicants who do not fulfill the established criteria will not receive any communication from durga puja adani preview 2026
- Rejected applicants may not contest the decision or demand explanations regarding their ineligibility
- Durga puja adani preview 2026 is not obligated to provide specific reasons for application rejection
- Repeated applications from previously rejected individuals may result in permanent ineligibility

11. Pass issuance policy

The issuance of preview passes is governed by the following principles:

- All passes are issued exclusively at durga puja adani preview 2026's sole and absolute discretion
- Decisions are based on internal criteria, venue capacity limitations, and curatorial considerations
- Durga puja adani preview 2026 reserves the right to limit the number of passes issued for any session or preview event
- Passes are non-transferable and valid only for the named individual
- Attempted transfer or resale of passes will result in immediate invalidation

12. Minors and attendees below 18 years

Special provisions apply for younger attendees:

- Attendees under 18 years must be accompanied by a parent or legal guardian at all times
- The accompanying adult assumes full responsibility for the minor's safety and conduct
- Parents/guardians must sign additional consent forms for minors' participation in interactive durga puja installations (if required)
- Durga puja adani preview 2026 reserves the right to request proof of age at any time

13. Children accompanying parents

For families attending with children:

- Couples or individuals attending with children must carry valid identification proof for each child
- Acceptable identification includes birth certificates, school id cards, or government-issued ids
- Children must remain under direct supervision at all times
- Strollers may be restricted in certain crowded or delicate designated preview areas

14. Accessibility

Durga puja adani preview 2026 is committed to providing an inclusive environment:

- Reasonable accommodations will be made where possible for attendees with disabilities
- Not all venues may be fully accessible
- Assistive devices are welcome in accordance with applicable laws

15. Intellectual property

Regarding the intellectual property associated with the preview event:

- All durga puja installations and creative content remain the intellectual property of their respective creators
- Unauthorized reproduction, distribution, or commercial use of any content is strictly prohibited
- Photography permitted for personal use may not be published, sold, or used commercially without written permission

Agreement and acceptance

By submitting the registration form for the durga puja adani preview 2026 pass, you explicitly acknowledge and confirm that:

- You have thoroughly read, fully understood, and unconditionally agree to abide by all terms and conditions outlined in this document
- You understand that failure to comply with these terms may result in the revocation of your pass and possible removal from events
- You accept that these terms constitute a binding agreement between yourself and durga puja adani preview 2026
